§ 1 Object of agreement

The object of agreement is the credit case along with its content (see inventory on the inside of the case's lid), as well as the video recordings generated by the beneficiary through the use of the credit case. The credit case together with its content remains the property of the credit bank.

§ 2 Terms of use and liabilities

Credit bank:

a.) The credit bank puts the credit case into circulation, by assigning its use to the beneficiary. Hereby it takes on the role of the first creditor. The seventh and last beneficiary will promptly return the case to the credit bank not later than on the seventh day upon its reception. Hereby the credit circulation CREDIT #3 has been completed after seven weeks.

Creditor:

b.) According to the inventory, the creditor assumes responsibility to the obligation of passing on the case only if complete and fully functional. Potential incompleteness or damage is to be immediately reported to the credit bank per telephone or email.

c.) The creditor explains the credit case and its use to the beneficiary. For this purpose, the instruction manuals enclosed in the case may be referred to.

d.) The creditor passes the credit case on to the beneficiary, minding the correct signing of the contract. The contract is to be signed each time in three copies. The third, intended for the credit bank, is inserted by the creditor into one of the enclosed jiffy bags, together with his/her used video tape and the envelope is handed in to a post office counter.

Beneficiary:

e.) According to the inventory, the beneficiary accepts the obligation of checking the completeness of the credit case. Potential incompleteness or damage is to be immediately reported to the credit bank per telephone or email.

f.) The beneficiary asserts to have been introduced to the use of the credit case by the creditor and pledges to carry out the tasks and rules listed in the CREDITcase instruction manual.

He/she especially pledges:

g.) to pass on the credit case to a new beneficiary not later than on the seventh day upon the reception of the credit case. Any person can be a successor and thus a new beneficiary, as long as they have your confidence and are able to meet the conditions of the contract. For persons under the age of 18 the respective legal guardian (e.g. parent) will sign the contract and mind its implementation.

h.) The beneficiary is given the right to freely use the case and its content during seven days, according to the rules listed in the CREDITcase instruction manual.

i.) The beneficiary cedes the video recordings produced during these seven days to the credit bank in place of interest payments.

Credit bank:

j.) The credit bank receives the full rights of use in regards to the produced video recordings, incl. the right of free editing and presentation. It will assemble the video recordings of all beneficiaries into a chain film CREDIT #3 and publish this in limited edition. Each beneficiary will receive one copy of the edition.

k.) The credit bank assumes responsibility to not make any financial profit with the edition of the chain film.

l.) Furthermore, the credit bank assumes responsibility for publishing the names of all beneficiaries in an appropriate place in each presentation. Should any beneficiaries oppose themselves to the publication of their name, then they will remain anonymous (In this case please underline the last sentence).

Beneficiary:

m.) At the end of the credit circulation, i.e. after an adequate period of editing, but not later than the end of the first public presentation of the chain film, the beneficiary will receive one copy of the edition of the credit film, CREDIT #3. He may donate this copy on to another person. Selling, modifying or copying the chain film is not permitted. However for safety purposes, one private copy may be produced. As the case arises, divergent arrangements can be made following a written agreement.

n.) The seventh and last beneficiary will promptly return the case to the credit bank not later than on the seventh day upon its reception.

§ 3 Final clauses

a.) Changes in the contract require written form. This contract appertains to the law of the Federal Republic of Germany. Legal venue is Berlin.
